Space for nonprofit organizations is complimentary and will be provided on a first-come, first-served, and space-available basis. The use of this space cannot conflict or compete with paying vendors. If a nonprofit chooses to sell food and/or drinks, the nonprofit must register as a Snack Food or Food Vendor, pay the Vendor fee, and provide an insurance certificate. If a nonprofit exhibitor chooses to sell merchandise, the nonprofit must pay a fee of \$150.00 with the Nonprofit application. ***Application fee for Nonprofit Information Vendor Space for a Nonprofit located in the Town of Madisonville will be waived. All Rules and Fees apply if Nonprofit sells merchandise or food. If accepted, you will be given TWO FESTIVAL PASSES FOR EACH DAY OF THE FESTIVAL. Any additional people with your organization must purchase tickets at the gate. There will be NO EXCEPTIONS.***

1. Nonprofit booth space is intended to allow 501(c)(3) organizations to promote their organizations only. You may not sublet or subdivide your space.
2. The Wooden Boat Festival will be held on October 23 and 24, 2010, from 10 am to 6 pm. Vendors may pick up packets on Friday, October 22, between 9:00 a.m. and 4 p.m. at Madisonville Town Hall on Water St. Booth must be set up on Friday during registration hours or on Saturday before 7:00 a.m. Parking during the Festival will be available at the Museum on Mabel Dr. with shuttle service to Water St. and Main St. No vehicles will be allowed on festival grounds at any time.
3. A 10' x 10' booth space ONLY is provided. Exhibitors must furnish their own tents, signage, tables, chairs, etc. Tents must be free standing, 10' x 10', with or without sides. For safety reasons, tie down lines cannot extend past your space.

The committee reserves the right to reject any application at their discretion.
